

# **TO PRESENT A PAPER**

Speakers are invited to submit abstracts of original, unpublished work for presentation at the Technical Sessions or at the Seminar. Commercialism in presentations is not permitted.

All abstracts must be submitted online via the dedicated portal accessible at www.eicf.org.

Papers shall be allocated to the Conference Sessions by the CTC (Conference Technical Committee). Sessions will consist of several presentations, with 20/25 minutes scheduled for each paper, plus 10/5 minutes for questions & discussion.

When assessing submitted papers, the CTC will consider:

- i. Originality and novelty of the subject
- ii. Innovation in material, process or product
- iii. Scientific outcome of R&D
- iv. Advances in manufacturing/management
- v. Use of Digitalisation and Al Tools (where applicable)
- vi. Comparisons with competitive processes and cast products
- vii. Standard of the paper and alignment with the conference theme

Presentations must be submitted in **PowerPoint** format (\*.pptx).

# People, Skills & Knowledge: The Future Workforce of Investment Casting

Abstracts can be submitted on the following topics:

- Innovation & Research: R&D projects advancing investment casting processes and applications; advances in casting simulation, predictive modelling, and defect reduction; digital twins and Al-driven foundry optimisation
- Materials & Process Development: new alloys and high-temperature materials for aerospace and energy;
   ceramics, refractories, and shell system innovations; coatings, waxes, surface treatments, and dimensional accuracy improvements; sustainability in materials
- Equipment and Process Innovations new equipment and technologies for improved process control, reduced variability, automation, and advanced inspection methods.
- New Management Practices & Competitiveness: innovative management approaches; supply chain resilience and risk management; ESG integration; case studies of business transformation
- Digitalisation & Automation: robotics and human–machine interaction; Industry 4.0/5.0; Al and data analytics for quality assurance and process improvement
- Additive Manufacturing : hybrid manufacturing approaches; certification and quality assurance; design flexibility; workforce skills and training needs

# **Abstracts Guidelines**

Abstracts Structure in the following format:

- 1. Abstracts should be no more than 250 words in length—not including Title, Author's name, or Company & Institution's name. This limit includes all text, spaces, and punctuation.
- 2. The text of the abstract should consist of a single paragraph. The abstract should be factual and informative. It should adequately summarise the work to be presented, including results and conclusions.
- 3.Ensure that all italics, superscript, subscript, and any special characters are in place before submitting an abstract.

# **Conditions**

The content of all abstracts will be refereed by the Conference Technical Committee, who reserve the right to reject a paper that does not meet its evaluation criteria. The inclusion of a paper in the final programme will also be dependent upon:

- i. the submission of the abstract and final presentation in requested format (\*.pptx) by the official deadlines
- ii. the receipt of the Licence to Publish Agreement by the deadline
- iii. the presenting author completing his/her delegate Conference registration and payment by fixed deadline.

### Note to Speakers:

All costs relating to Conference participation, including registration (special rate for Speakers), travel accommodation and subsistence expenses, to be covered by the Speaker.

#### **About Seville**

Seville, capital of Andalusia, is one of Europe's most historic and vibrant cities. Known for its rich cultural heritage, architectural landmarks such as the Alcázar and the Cathedral, and a thriving modern economy, Seville offers an inspiring backdrop for this international event. Seville has a municipal population of about 686,741 as of 2024, and a metropolitan population of about 1.5 million, making it the largest city in Andalusia and the 5th-largest city in Spain. Its old town, with an area of 4 square kilometres, contains a UNESCO World Heritage Site comprising three buildings: the Alcázar palace complex, the Cathedral and the General Archive of the Indies. The Seville harbour, located about 80 kilometres (50 miles) from the Atlantic Ocean, is the only river port in Spain.

Its unique blend of tradition and innovation mirrors the conference theme: the future of investment casting shaped by the skills and knowledge of its people.
